## Joint Press release

### **Leading law schools in Australia, Hong Kong and Singapore join hands to form Research Alliance on Law and Sustainability to drive research and teaching in the Asia-Pacific region**

*Australia, Hong Kong, Singapore on 13 July 2023 (Thursday)* – Singapore Management University (SMU) Yong Pung How School of Law (YPHSL); Sydney Law School, University of Sydney (USyd); and Faculty of Law, The University of Hong Kong (HKU), today announced the formation of the **Asia-Pacific Research Alliance on Law and Sustainability**, a first of its kind in the Asia-Pacific region, with an aim to drive law-focused research and teaching initiatives on achieving sustainability for this part of the world.

The announcement was made at the inaugural [Law and Sustainability Conference](#) titled 'Law in a hyperconnected world – joining the dots for a sustainable future'. Organised by SMU YPHSL, with the support of Sydney Law School and HKU Law, this is the first of a three-part conference series and is a starting point for the Research Alliance to advance its agenda.

It is also the first event of the [SMU Sustainability Series 2023](#) (details in Annex 2). The Series comprises a curation of sustainability-focused events to be held between July and October 2023, through which the University will engage with stakeholders and partners to further the discourse on sustainability and to showcase the key milestones it has achieved, as charted out in its [Sustainability Blueprint](#).

The two-day conference, which was graced by Singapore's Ambassador-at-Large Professor Tommy Koh as its Guest-of-Honour, will showcase more than 50 speakers selected from nearly 100 paper submissions from Australia, Brazil, China, Germany, India, Indonesia, Kenya, South Africa, Slovenia, Spain, Sri Lanka, the United Kingdom and Peru.

The opening day of the conference also featured a Keynote Address by Dr Lena Chan (Senior Director, International Biodiversity Conservation Division, National Parks Board, Singapore) who spoke on 'Weaving a Tale of Three BiodiverCities' and Singapore's role in the development of the Convention on Biological Diversity's Singapore City in Nature Index and of urban sustainability.

This was followed by a plenary where leaders of the three universities – SMU President, Professor Lily Kong; USyd's Associate Dean Education, Professor Nicole Graham; and HKU's Head of Department of Law, Professor Zhao Yun – discussed the critical role played by universities in sustainability education; as well as an industry panel featuring representatives from WongPartnership, Johnson Controls, Musim Mas Group and World Wide Fund for Nature Singapore, who gave their perspectives on sustainability and ESG in business, finance, legal practice and governance.

#### Asia-Pacific Research Alliance on Law and Sustainability

Following the two-day Conference, the Alliance will be producing in 2024 a Special Issue with some dozen papers to be published by *Review of European, Comparative and International Environmental*

*Law*, one of the top journals in the field. In 2024 and 2025, USyd and HKU will respectively play host to the remaining parts of this conference series.

Elaborating on the motivations behind the multi-university collaboration, Professor Lee Pey Woan, Dean of YPHSL, said, “Technological advancements and globalisation have made a profound impact on the movement and exchange of information, ideas, goods and people. This has led to a significant transformation of the Earth's natural systems, posing a severe threat to the ability of these systems to sustain life on Earth. Despite these pressing challenges, legal systems at both the international and domestic levels have remained entrenched in the generations during which they were formed. It is therefore crucial for scholars and policymakers to envision new legal and governance systems that recognise the interconnectedness of multiple sectors, anticipate the far-reaching effects of global environmental change, and address the unprecedented social and ecological disruptions we face today.”

### Sustainability Law elective

Recognising that sustainability law goes beyond environmental law, and incorporates environmental, social and economic considerations to develop legal solutions for achieving harmony between human and nature, SMU YPHSL will introduce a new Sustainability Law elective for all law undergraduates in January 2024. The course will familiarise students with the environmental, economic and social dimensions and intersections for sustainability and various streams of law and policy. They will gain exposure to a range of current developments involving sustainability locally and globally, while reflecting on current laws and policies that address them. (Please see Annex 1)

On 15 July, the conference scholars, together with some first-year SMU law students, will participate in a tree planting programme in support of the Singapore 2030 Green Plan’s [OneMillionTrees movement](#). The tree planting activity will be a particularly meaningful restoration effort, as the 10 trees to be planted are specially selected native species which resemble the original Fort Canning Hill habitat that pre-dates the Javanese settlement. Updates on the trees will be provided to participants at the subsequent editions of the conference series in Australia and Hong Kong, in 2024 and 2025 respectively.

**Course Description**

In recent years, sustainability has become a popular buzzword in society. The need for sustainable development is quickly emerging as an area of focus among businesses, organisations, governments and the media. This course will introduce students to the fascinating environmental, economic and social dimensions and intersections for sustainability and various streams of law and policy. Students will gain exposure to a range of current developments involving sustainability locally and globally, while reflecting on current laws and policies that address them.

**Course Methods**

Over the course of weekly 3-hour seminars, students will explore the environmental, economic and social dimensions and intersections between sustainability and the different fields of law and policy through meaningful discussions, research and sharing of current real-life topics and developments. A field trip may be arranged to enrich students with their perspectives.

#### **Law in a hyperconnected world – joining the dots for a sustainable future**

*Jointly organised by: SMU Yong Pung How School of Law; Sydney Law School, University of Sydney; and Faculty of Law, University of Hong Kong*

*Guest-of Honour: Professor Tommy Koh, Singapore Ambassador-at-Large*

Our planet faces social-ecological disruption at a scale with no parallels in human history. As societies, economies and the environment are inextricably linked, it makes no sense to regulate each of these systems in isolation. Various global reports, such as the United Nations' Environment Program's Making Peace with Nature, the Joint report on biodiversity and climate of the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services, and the Intergovernmental Panel on Climate Change, all highlight the failure of governance systems to address interconnected global challenges in a holistic manner. The reports also highlight the perverse outcomes that result from the lack of integrated approaches.

With all of the above in mind, it is critical that new forms of laws and regulation, governance, societal organisation, communication, and the transfer of ideas and capital are taken into account when aiming to address sustainability. Laws at the international, transnational and domestic level are, however, currently ill-equipped to address the hyperconnected challenges of today, and do not sufficiently anticipate the emerging risks and opportunities of the future. It is to this gap that this Conference seeks to contribute.

#### **Beyond the Tipping point: Envisioning a hotter world and how technology will be a key to adaptation**

*Jointly organised by: SMU and Vertex Holdings*

Despite the world's efforts to reduce greenhouse gas emissions, scientists predict that we will hit the 1.5°C tipping point in the 2030s, leading to an irreversible change in our climate system. What happens if we cross that tipping point? What implications would the devastating environmental changes have on the global economy, supply chains, cities, and societies? How can we leverage technology and innovation to bridge the gap today, in preparation for the worst-case scenario?

A partnership between SMU and global venture capital investment company Vertex Holdings, this thought leadership forum aims to leverage the knowledge and expertise of speakers from diverse backgrounds in a discourse on imagined futures, exploring scenarios where the world copes with living in a hotter and hostile world.

**Launch of SMU Master of Sustainability and Second Major in Sustainable Societies**

Inspired by the United Nations Sustainable Development Goals (SDGs), the Master of Sustainability (MST) and Sustainable Societies (SS) second major aim to inspire an appreciation and sense of urgency about the complexities, trade-offs, and synergies that sustainability presents for the people and the planet that we inhabit.

The MST is the first-of-its-kind programme that leverages the research and pedagogical strengths of SMU's School of Social Sciences and College of Integrative Studies to offer a postgraduate sustainability curriculum that is built on interdisciplinarity and problem-solving in the face of complex challenges. The programme will inculcate crucial skills in the areas of sustainability reporting, systems thinking and collaborative governance, in recognition of the evolving nature of sustainability roles across sectors. The SS second major has three main pillars – environment, society and the economy – which mirror the realities and challenges of sustainable development of today and the future. By emphasising problem-solving capabilities and interdisciplinarity rooted in the social sciences, this second major aims to develop in students the skillsets for future green jobs across industries and sectors.

11 to 14 September 2023

**11<sup>th</sup> edition of the Lee Kuan Yew Global Business Plan Competition (LKYGBPC)**

*Organised by: SMU Institute of Innovation & Entrepreneurship*

LKYGBPC, held once every two years, is one of the largest university-led start-up competitions in Asia with a mission to empower youths through innovation and entrepreneurship to create deep-tech solutions to solve urgent global challenges of the 21st century.

This year, the competition received 1,000 global submissions from 77 countries. Close to 90 per cent of the submissions incorporate sustainability solutions and reflect SMU's commitment to the United Nations' Sustainability Development Goals. These entries leverage cutting-edge technology to drive environmental change. The strong interest illustrates that our next generation of entrepreneurs are actively contributing to environmental preservation by harnessing technology to minimise carbon footprint globally.

The LKYGBPC Blaze Week will also feature several sustainability-focused events:

- 11 Sep 2023 – As part of the Opening Ceremony, a book featuring selected past finalist startups which are involved in improving urban sustainability, will be launched.
- 13 Sep 2023
  - Changemakers Conversations – Built Environment Panel  
Held off-site at Kajima Asia Pacific's Innovation Centre, the forum will delve into innovative approaches and practical solutions that go beyond mere carbon neutrality to create positive environmental outcomes in the context of the built environment. Panelists will explore strategies, technologies, and policies that can be implemented to achieve sustainable development goals and foster environmental stewardship.
  - Site Visit: On the same day, participants will also have the option of visiting the Sembcorp Solar Farm.

### **Finals of SMU-Next Gen ESG Case Competition 2023**

It will also serve as a platform and catalyst for knowledge exchange, idea empowerment, deep dialogues and fruitful partnerships among industry players, local non-profit and community organisations, researchers, educators and stakeholders in the sustainability space.

Parts of this forum are co-planned with student leaders who participated in the SMU Pathfinders Sustainability Changemaker programme in December 2022. The event will also feature student displays and student presentations of their sustainability projects or learning experiences.

*Theme: Build an emotional compass – Navigate your journey to mental wellness*

*Organised by: SMU*

During this week, there will be activities and events held campus-wide to raise awareness of mental well-being, a key to building resilient communities.

A Mental Health Fest will be held on-campus, comprising an interactive exhibition where participants can view informational material and engage in hands-on activities to develop emotional resilience, such as a feelings wheel (to promote emotional literacy), a conversation card game (to process emotions and reframe beliefs towards more constructive outcomes), an area to relax and practise relaxation techniques and mindfulness, as well as a space to write notes of appreciation and regulate emotions through colouring and play.

Other fringe activities include: Human Library (SMU alumni will be invited to share how they juggle career and personal wellbeing); Cafe Conversations (conversation starters will be placed in participating cafes in SMU to encourage patrons to engage in meaningful conversations); massage sessions by people with visual impairment; as well as talks and workshops on desk stretch, office pilates and sound bath therapy to encourage the SMU Community to take care of their wellbeing at work.

**3<sup>rd</sup> ROSA Annual Symposium on Successful Ageing - *Supporting active ageing in our communities***

The Singapore Ministry of Health released the 2023 Action Plan for Successful Ageing in January 2023. The Action Plan, refreshed eight years after its first release in 2015, focuses on the central idea of empowering older adults to remain active, be it through caring, contributing, or staying connected, is a central idea.

Accordingly, the theme of this 3<sup>rd</sup> annual symposium will explore how we can better support older adults in Singapore to remain active in their later life, with being 'active' defined broadly and consisting of three key components: (1) Staying physically and mentally active – being able to stay healthy and to continue participating in regular activities; (2) Staying socially active – being able to stay integrated within and connected with their communities; and (3) Staying economically active - being able to continue to contribute to their communities.
